01 CHAIRMAN'S WELCOME AND ANNOUNCEMENTS.

The Chairman welcomed all present.

02 APOLOGIES

None.

05 PUBLIC PARTICIPATION SESSION

Heavy Duty Vehicles

It has been observed that there are an increased number of heavy duty vehicles coming through Sheriffhales Village. There are 7.5 tonne limit signs and accepting there would be deliveries within the area there still seems an abundance of vehicles. It was identified that satnav's direct vehicles along roads which are not always appropriate.

The Chairman suggested that evidence is key and if possible to take photographs, dates, times and vehicle company names and present to the police or safer roads partnership. Cllr J Horne said this issue had been raised at LJC meetings many times and the police do not consider this as a matter for them to pursue, safer roads should be able to assist. Cllr G Tonkinson re-iterated the need for a 20mph speed limit and a pedestrian crossing in the village.

Dog Grooming parlour and kennels, Crackley Bank

Concern has been raised with regards to the business that has opened near junction. The main concern is the restricted access onto this property, which is causing obstructions and an increased risk of an accident at the Crackley Bank cross roads. This is already a dangerous junction. There have also been instances of vehicles parking on the grass verge by the property.

So far this is a new business, however when dogs have been staying in the kennels there have been instances of them barking throughout the night which is disturbing local residents. This will only get worse now that more kennels have been constructed and the kennels get busier. Only this week a dog had got loose and was on the road.

It is also believed that the owners / managers are living in the garage which is questioned if there is planning permission for.

Shropshire Councillor K Turley confirmed this is on the agenda for Shifnal Town meeting next week as a retrospective planning application has been received.

Cllr G Tonkinson said the junction is already dangerous and causing concern and now this had added to issue. There are aerial photos which show the development has grown and will be reviewed as part of the retrospective planning application with Shifnal Town council.

A41 Woodcote Corner

Shropshire Cllr K Turley has observed that it appears that clearing work is being undertaken at Woodcote Corner, plants have been cut back. It appears that there could potentially be work due to start at quarry site and it was asked for the council to remain vigilant.

Bin

Mr P Young asked for the council to consider purchasing a wheelie bin for outside the cemetery. Cllr J Horne suggested getting a quote and being mindful that we may be charged commercial rate. **ACTION** clerk to get quote and feedback to councillors.

Notice Board - Heath Hill

Mr S Garbett asked the council to consider placing a notice board at Heath Hill. **ACTION** clerk to get further information.

Parish Council Champion

Mr S Garbett asked if any councillor would support the church and act as a liaison with Shropshire County Council with regards to matters such as footpaths and maintenance around churchyard. The council <u>AGREED</u> that not one particular councillor would be nominated but the council as a whole would be a "Champion". It was requested that when support is required to pass details onto the clerk who can then circulate to councillors and respond accordingly.

17 APPOINTMENT OF INTERNAL AUDITOR

18 **ROAD SAFETY**

Cllr R Maddocks has observed that the roads in general are worsening and in a bad state of dis-repair. It was agreed to defer to next meeting.

The Chairman readout an email dated 03rd March from A Dilly with regards to parish council comments about road safety in Sheriffhales. Cllr G Tonkinson is concerned that tractors and

buses will find the road too narrow. **ACTION** the clerk will ask for a copy of the latest drawing and put a copy on website and notice boards.

It was suggested that the parish council invite Traffic Engineer – Graham Downes to meet with councillors and re-iterate concerns over Crackley Bank and any other road safety issues. The clerk will liaise with Shifnal Town Council with regards to any meetings arranged.

19 **NEIGHBOURHOOD PLAN**

Cllr A MacWhannell agreed that he would lead on the Neighbourhood plan but would need support as the amount of work is considerable. It was decided to await new council to be appointed and then look at forming a sub-committee to undertake project.

20 PLAYGROUND EQUIPMENT

- Update on planned work
 Work on refreshing the playground has started this week.
- ROSPA inspection
 It was <u>AGREED</u> to appoint Shropshire County Council to arrange inspection to be undertaken in the summer.

21 ENVIRONMENTAL MAINTENANCE GRANTS PROGRAMME 2017/18

Applications are being sought for grant. In 2016/17 the parish council received £1,155. However this forthcoming year there are a number of projects being undertaken such as works to the footpaths and play area. It was **<u>DECIDED</u>** to apply for the maximum £3,000. **ACTION** clerk to submit application.

22 **SMELL IN THE VILLAGE**

A record of incidents has been kept by the clerk (copy tabled at meeting). The smell still persists and councillors are being regularly approached with regards to the matter. It was **AGREED** that an article will be placed in the parish magazine to gauge how widespread the issue is. An update will be given to the Environmental team.

23 **DELEGATES REPORTS**

The Chairman has received two letters

- A request for a donation to Tong Parish Council.
 The Chairman read out the request. It was <u>AGREED</u> not to make a donation as funds are committed for our parishioners. The clerk will respond and suggest that they approach the V-Festival promotors for a contribution.
- <u>Village Hall extension</u>
 The Chairman read out a letter he had received regarding concerns over the village hall extension. It was <u>AGREED</u> that this should be forwarded to the village hall committee for their consideration.
