163/14 CHAIRMAN'S WELCOME AND ANNOUNCEMENTS.

164/14 **APOLOGIES** – Cllr Horne will be late: Shropshire Councillor Kevin Turley (unwell)

165/14 **DISCLOSABLE PECUNIARY INTERESTS** – There were none.

Cllr Horne arrived at the meeting.

166/14 **DISPENSATION** – There were none.

167/14 **PUBLIC PARTICIPATION SESSION** – An opportunity for the public to speak to the Council on matters that concern the Parish.

The Chair introduced Berries representative who outlined planning application 15/00100/OUT to the members. The outlined planning application would be for family size houses to be decided at a later date. Affordable dwellings would be considered and the development was sustainable as it had a school, church and post office.

The residents and Chair highlighted the fact that this development was outside the development boundary and Sheriffhales does not have a post office as stated in the report with the application. Berries apologised for the incorrect information within the report.

A resident reported that this application was not only outside the development boundary, but did not comply with the Parish Plan and was very disappointed that Shropshire Council Planning had validated these applications.

Berries representative informed the Parish Council and residents that they would take back all the points raised.

Cllr Tonkinson reported that Outlined planning applications do not state the details, but he understands that this comes later. This planning application is a good distance outside the development boundary and we would like local low cost houses, not for people coming for miles away. Although the application has been validated, it still needs to get permission and does not comply with our policies CS5 or the Parish Plan. Cllr Tonkinson was concerned that once you agree to building outside the development boundary, where would it stop.

Cllr Pulker is not actually against it, but was concerned that once this field is developed, it could continue to be developed further.

Resident – both the planning applications fall outside the development boundary. The site is not infill and the previous applications have been refused.

A resident said that this is not sustainable and will Berries withdraw this. Berries representative reported that it was sustainable as it has a primary school, church, bus service and close to other towns and amenities and they will not withdraw this.

Both planning applications are outside the development boundary. Chair reported that the development boundary CS5 is the edge of the Parish.

Applicant: Mr Andrew Gough (Atwell Park Farm, Sheriffhales, Shifnal, Shropshire, TF11 8RQ) **Decision:** Cllr Webb **PROPOSED** that the Parish Council object to this application on the grounds that it runs against the wishes of the parish and numerous other objections; the fact that the developer cannot confirm at this time whether it will be low cost affordable housing, being the only option that might be even considered by the parish, makes refusal the only option. Cllr Tonkinson **SECONDED** Cllr Webb's proposal and added that it was an unacceptable development. After a show of hands, 1 in favour, 5 against and Cllrs Mrs Jones and Maddox asked that it was minuted that they abstained. The application was not supported.
