06 SMART WATER "We don't buy crime" PRESENTATION

This joint initiative with West Mercia Police was presented by PC Simpson. Property could be marked and registered using this material allowing subsequent identification. Signage would be provided free of charge for distribution within the Parish as part of this initiative to reduce crime. This will be an agenda item next meeting.

07 PUBLIC PARTICIPATION SESSION

Members of the public raised concerns about the following.

Lack of maintenance of the area around The Wayside Cross at Heathill, the need for further trimming back of playing field hedges and agricultural traffic speeding through the village of Sheriffhales.

A request was made on behalf of the school to consider trialling temporary toilet facilities on the playing field for school use only. A trial period of six weeks being suggested.

16 TO RECEIVE REPORTS ON ROAD SAFETY AND RELATED ISSUES AFFECTING PARISH

Burlington junction

Visibility at Nanny Murphy's Lane when exiting onto the A5 remains a problem, and further minor accidents have taken place over recent weeks and months as increased levels of traffic have come from Shifnal due to the closure of Coppice Green Lane at Idsall. Shropshire Council Highways is aware of problem is taking forward suggestions put forward at minimising danger.

Back Road Culvert

The council received an updated report on the closure and awaits further response from the Highways department when more work on feasibility of options available has been done.

Crackley Bank traffic congestion

The Safer Roads team to be asked for junction evaluation due to continuing concern about congestion and accident risk at this location. **ACTION** clerk to submit request again for this year. The clerk has requested meeting with Shifnal Council to look at joint working again. **ACTION** the Chairman will write directly to Shifnal Chairman to ask for a meeting.

20 is plenty campaign

Participation in the 20 is plenty campaign was discussed and supported in principle. It was <u>AGREED</u> to defer until local school involvement could be established and introduce if practical at a time that coincided with new road layout which is coming in later this financial year.

Road surface deterioration Evergreens

It was noted that the state of the road still presents an issue and Shropshire Council have reassessed and will add it to schedule of works.

Hales Court parking and related issues

The Chairman has received correspondence relating to obstruction of visibility, parking for residents and associated matters. The Chairman **PROPOSED** that he would liaise with Star Homes. Cllr K Turley **SECONDED** all **AGREED**.

17 ENVIRONMENTAL AND RELATED ISSUES AFFECTING THE PARISH

Obstruction of Footpaths had been reported and correspondence forwarded to County Council for any necessary action. It was noted that following previous correspondence the Parish Council had asked for an update on measures undertaken to reduce environmental impact from Pig Farming at Meadow Farm. No reply had been received. A Log of incidents relating to this environmental nuisance and reported to the Parish Council continues to be kept. Following further concerns expressed directly Cllr Turley will be taking forward with appropriate County Council Departments.

After requests from the Parish Council Shropshire Council Environmental Health team have been investigating reported problems with rats at the site of empty property in the centre of the village.

Woodcote Quarry

The clerk reported that she had invited representation from Shropshire Council to this parish council meeting given concerns locally about work being undertaken at the proposed Quarry Site. Correspondence received indicated there was no update to provide as yet and so attendance at this time would not be of value.

It is noted that further information did become available about this major issue shortly after the meeting. This was not available to the Parish Council at the time this meeting was held
