13/15 PLANNING APPLICATIONS –

Reference: 15/01366/FUL (validated 27 .03.15)

Proposed: Installation and operation of a solar farm and associated infrastructure

Location: Proposed Solar Farm to the West of Sheriffhales.

Applicant: Lightsource SPV 39 Limited

Resident Peter Ward explained the difference between the levels of land stated in the application. If there was to be a fence put round the field the public footpath could not been used. Cllr Tonkinson gave his objections as follows:

- 1. Totally inappropriate use of good agricultural grade 3, 3A and 3B land, where excellent and high yielding crops such as wheat, oil seed rape, barley, oats, grass are produced year by year on immediately adjacent land.
- 2. On farm BIO Digester Plants are being set up across the country to use waste residues from crops and crops grown specifically for such use. They produce electricity 24 hours per day so much more efficient and dependable than relying on the sun to shine and very short daylight hours in winter.
- 3. The size of the site, 44 acres is totally out of scale and character with anything in our very rural Parish of Sheriffhales, thus bringing industrialisation into farmland. It will have serious visual impact.
- 4. Such developments should be on Industrial/Factory Roofs and there are thousands in Shropshire where most of the power could be used on site.
- 5. None of the power that would be produced is for use on the farm involved in the application. Therefore, this proposed development would purely be taking good land away from the production of food.
- 6. On 25 April 2013, the Minister for Energy, the Rt. Hon. Gregory Barker, MP quoted "the Government will focus deployment of solar panels on buildings and brown field land". This is now reconfirmed by the Secretary of State for the Environment, Liz Truss "that good agricultural land should not be used for Solar Panels, but for producing food".
- 7. The site can be seen from adjacent paths, from the Young Persons Education Facility (at Big Wood), the centre of Sheriffhales Village, Pinfold, The Evergreens, Church Lane, Dukes Drive, Crackley Bank to the Lilyhurst Road, the A5 Crackley Bank, Sandy Lane, Red Hill, Haughton hill, Decker Hill and near to the Crematorium.
- 8. Any guaranteed financial offer from the developers to the Parish Council will only be accepted

if any permission is given by Shropshire Council decision, other than to note the offer.

Cllr Webb would like to add the following to Cllr Tonkinson's objections. This proposal is robbing the poor to pay the rich. It takes advantage of an obsolete and morally bankrupt government policy, now being withdrawn piecemeal, which is charging electricity customers to line the pockets of investors, disadvantaging the poorest in society the greatest.

Cllr Bonsall reported that he had spoken with Lightsource regarding the Community Ownership Opportunity and explained this to the members present.

After further discussion a vote of hand was called by the Chairman. 7 objected to the planning application and one was in favour. It was **AGREED** to use both Cllrs Tonkinsons and Webbs objections above in a letter of objection from the Parish Council.

This has been shared with Mark Smith who has pulled together a working document for discussion and approval. Mark reported he had put everything together and produced a document but now needs to be consulted with the community for feedback. It was suggested that the existence of the Parish Plan to be advertised in the Newsletter asking if they would like an electronic version or a hard copy. Mark would set up an e-mail address for this purpose. Mark handed this document out to the members, but he will also e-mail it out as well.
