<p>Contracts</p> <p>Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest⁴) and the Council—</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharged.</p>	<p>No</p>
